<p style="text-align: center;">STIPULATED MOTION FOR ENTRY OF ORDER EXTENDING DEADLINE FOR RETURNING CLAIM AND RELEASE FORMS</p>	

The parties, by their undersigned counsel, jointly move this Court for entry of an Order extending by three weeks the deadline by which members of the settlement class (“Settlement Class Members”) must submit signed Claim and Release forms. In support of this Motion, the parties state:

1. On June 22, 2005, this Court entered a Final Judgment Approving Settlement, Awarding Attorneys’ Fees and Costs, and Terminating Litigation (the “Judgment”). Paragraph 9 of the Judgment directed the parties to send a Notice of Settlement in the form attached thereto to all Settlement Class Members. Paragraph 12 of that Judgment provided that the Court, without affecting the finality of the Judgment, reserved continuing jurisdiction over the Action for purposes of, among other things, supervising the Judgment’s implementation.

2. In accordance with the Settlement Agreement entered into by the parties and approved by the Court, the Notice of Settlement sent to Settlement Class Members specified that such members must return the completed and signed Claim and Release forms to the Claims Manager postmarked on or before next Tuesday, November 22, 2005. More than 80 percent of all Settlement Class Members have signed and returned those forms to date. Settlement Class Members who do not timely return those forms will be bound by the Judgment dismissing with prejudice all claims asserted on their behalf in the case, but will obtain neither of the benefits potentially available to them under the settlement, *i.e.*, \$300 and free lifetime long distance telephone service from Qwest.

3. The parties jointly seek to extend the deadline for submitting signed Claim and Release forms by three weeks, to and including December 13, 2005, so that Settlement Class Members who have not yet returned those forms will have additional time within which to do so and thereby obtain (if they wish) the benefits of the settlement approved by this Court.

WHEREFORE, the parties respectfully request that the Court enter an order extending the deadline for submitting Claim and Release forms by three weeks, from November 22 to December 13, 2005. A proposed form of Order accompanies this Stipulated Motion.
